

**Regular Meeting  
April 10, 2017**

The Board of Trustees of New Plymouth School District #372, Payette County, Idaho, met in the High School Library on April 10, 2017 at 6:00 p.m. Members present were Gary Johnston—Chairperson, Nadine Horton—Vice Chairperson, Arlo Decker, Dave Brogan, and Ron Kovick (conference call)

***Call to Order***

The Meeting was called to order by Gary Johnston—Chairperson.

***Self-Declaration of Open Meeting Violation***

\*\*A motion was made by Dave Brogan, and seconded by Arlo Decker to declare an open meeting violation and declare action Void.

The vote was unanimous, and the motion carried.

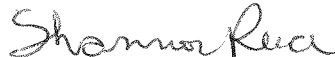
#### ***Adjourn***
